

## + Why choose this course?

Turn your passion for caring and supporting others into a rewarding career in the healthcare industry. This course provides you with the current skills and knowledge in order to fulfil the registration requirements of the **Nursing and Midwifery Board of Australia (NMBA)** and to practise nursing in a variety of settings, including mental health, primary health, acute care, aged care and palliative care areas. You will gain all the requirements aligned to current industry trends and will graduate with the following skills and knowledge.

- » How to assist in the provision of preventative, curative and rehabilitative nursing.
- » An understanding of anatomy and physiology.
- » How to implement infection prevention and control measures.
- » How to provide nursing care for the client.
- » How to understand Australian legal and ethical parameters of nursing practice.
- » How to provide person centred care where independence and empowerment are fostered.
- » How to implement culturally safe care for Indigenous Australians and Torres Strait Islander people.
- » How to contribute to the care of people with mental health issues.

A large component of your studies consists of a clinical placement where you can practise your skills and attributes. Upon completion of this course you will have the skills and knowledge required to become a qualified enrolled nurse.

All students enrolled in the HLT54121 Diploma of Nursing course are registered with the Australian Health Practitioner Agency (AHPRA) for the duration of their course. On successful completion of all course requirements, you may be eligible for registration with the Nursing and Midwifery Board of Australia (NMBA).

## In Australia, nursing qualifications are accredited by the Australian Nursing and Midwifery Accreditation Council (ANMAC). ANMAC is accountable to the Nursing and Midwifery Board of Australia (NMBA) for assuring the Australian community that graduates of accredited programs can practise and care for people in a safe and competent manner.

ANMAC accredits nursing qualifications in accordance with a set of standards. Please refer to their website for more detailed information.

Please note that the Nursing and Midwifery Board of Australia (NMBA) requires you to have an IELTS score (academic module) with a minimum overall score of 7.0 and a minimum score of 7.0 in each of the four components (listening, reading, writing and speaking) to meet their registration requirements.

## Admission requirements

You will be required to:

 undertake Basic Key Skills Builder (BKSB) Literacy & Numeracy assessment testing, and achieve exit level score of 3 (working at level 4) in Language, Literacy and Numeracy. If you have provided a formal English Language result (jn the list below) you are only required to complete the numeracy component.

#### English language requirements 1. English language test pathway

You must have successfully completed one of the following English language tests:

- » an IELTS score (academic) of 7.0 with no band score less than 7.0;
- » Occupational English Test (OET) with minimum score of B in each of the four components;
- » PTE Academic with a minimum overall score of 65 and a minimum score of 65 in each of the four components; or
- » TOEFL iBT at a minimum overall score of 94 with reading at a minimum of 24, listening a minimum of 24, speaking at a minimum of 23 and writing at a minimum of 27; or

## 2. Primary language pathway

» have attended and satisfactorily completed at least six years of primary and secondary education taught and assessed solely in English in any of the following countries: Australia, Canada, New Zealand, Republic of Ireland, South Africa, United Kingdom and the United States of America. At least 2 years of study must be between Years 7-12.

## Academic results

You must have achieved the minimum of:

- » the equivalent of Australian Year 12 with a pass in Year 11 Maths; or
- » completion of the 52895WA Certificate IV in Preparation for Health and Nursing Studies.

## E Additional requirements

Please note there are additional costs to pay when enrolling in the Diploma of Nursing:

- » you will have text books to purchase and details of these will be provided at orientation.
- » you may be required to complete a health check (approx. \$200)\*
- » you may require immunisations and/or provide evidence of vaccinations - COVID-19, Hepatitis B, Measles, Mumps, Rubella, Varicella and Diphtheria, Tetanus, Pertussis (DTP) record of vaccination (cost will vary depending on your doctor and what vaccinations are needed)\*
- » Methicillin Resistant Staphylococcus Aureus (MRSA) Screening Test (if required) (\$37)\*
- » Working With Children Check (WWCC) (\$11)\*
- » National Police Certificate through WA Police website only (\$57.60)
- » NDIS Worker Screening Check (\$11)
- » WA Health Department Criminal History Record Check (no cost if applied for post Police Certificate)\*
- » Uniform Scrub Top and Pants (\$70.50 per set) and closed in slip resistant shoes. Details of these will be given at orientation.

## 된 Please note

To protect the public from harm, registered health practitioners and education providers must report concerns about registered students. This is a legal requirement. Practitioners and education providers only need to notify Australian Health Practitioner Regulation Agency (AHPRA) when they have a 'reasonable belief' that a student has an impairment that, when undertaking clinical training, may place the public at substantial risk of harm.

The Australian Nursing and Midwifery Accreditation Council (ANMAC) Enrolled Nurse Accreditation Standards 2017 also require Registered Training Organisations (RTOs) delivering HLT54115 Diploma of Nursing to notify AHPRA of any student undertaking clinical training who has been identified as having an impairment that may place the public at substantial risk of harm.

AHPRA will be advised of the names of all students undertaking the Diploma of Nursing.

Upon completion of the course and a minimum of 400 hours of work placement, graduates will need to seek registration with AHPRA to work as an enrolled nurse, or to enrol in further study to become a registered nurse. The Nursing and Midwifery Board of Australia (NMBA) has developed core registration standards that define the requirements that applicants, registrants or students.

NMBA states that with the exception of registered students and non-practising registrants, these standards apply to applicants for registration and currently registered nurses and midwives.



## Learning resources, facilities and equipment

## Fee information

There are three types of fees required.

- » Tuition International student tuition fees are set on a commercial basis and are paid as a whole of course fee.
- » Resource These are mandatory fees paid to your TAFE college each semester. These fees are a fixed payment determined by each unit of enrolment. Resources fees are charged for items you will use during your course, for example if you are studying a hospitality course it will be the food that you use; or an art and design course may include paint.
- » Materials These fees are for materials you will keep for use during and after your studies, for example personal protective equipment, text books, uniforms etc.
